#### Structure, governance and management.

The method of appointment of PCC members is set out in the Church Representation Rules. All Church attendees are encouraged to register on the Electoral Roll and stand for election to the PCC.

#### **Objectives and activities**

St Andrew's Church, West Wratting PCC has the responsibility of co-operating with the Priest in Charge in promoting in the ecclesiastical parish the whole mission of the Church, pastoral, evangelistic, social and ecumenical. It also has maintenance responsibilities for the Church building, churchyard and surrounding areas bounded by St Andrew's, West Wratting.

#### Achievements and performance

#### Church attendance

There are 29 parishioners on the Church Electoral Roll. The average attendance in 2024 was 15 adults. We had larger attendances at Songs of Praise. We hold at least One Sunday morning service and one Evensong each month.

### Review of the year 2024. The Secretary's report of the PCC

During 2024 the PCC met 4 times. The main subjects of discussion were (1) Reviewing the work necessary as a result of the Quinquennial review; (2) The highly successful Harvest Supper in part in aid of the fabric of the Church which together with the sums raised at the Auction of Promises in 2023 will enable those works to be done; and (3) the appointment of Hannah Threlfall as the Community Minister.


The PCC decided to continue without the formal appointment of a Churchwarden.

The pattern of regular worship was maintained with a service twice a month led by a member of the Clergy Team together with the Benefice service on the first Sunday.

Songs of Praise services attract excellent attendances. We extend our thanks to Scilla and John Harvey for leading and arranging the popular Songs of Praise services and to the many musicians, drawn from Rock Baptist Church, Linton Free Church and Christ Church Trumpington, who help to enliven these services.

St Andrew's faces ongoing challenges, especially financial ones. The Treasurer's report details the many challenges we have in the coming year, it will be vital to look at our fund-raising efforts and to seek a review of regular giving through covenants. We are grateful to all those who support the church in many ways. We thank Gary Birditt for being our Treasurer and Ian Creek for being our Independent Auditor.

The day to day running of the church relies on an increasingly small group of people, whose ongoing commitment and willingness to provide assistance cannot be taken for granted; we are all deeply indebted to them.

We need to plan for the future in terms of the succession of office holders and to increase the membership of the PCC.

We are grateful to Sisse McCall for maintaining the Rota of opening and closing of the Church to ensure visitors can have access, and Cobby McCall for arranging the Church tidy ups and keeping the Church yard looking so beautiful. We thank Linda Gorman for continuing to organise the rota for flower arranging. We thank Mark Addley for his on-call support with numerous tasks and specifically keeping the Clock tower in working order. Di Edwards has continued to support with arranging electrical repairs and fire extinguisher maintenance. Sincere thanks to all.

Thank you to everyone who has supported the church throughout the year in every capacity; all your love, contributions and endeavours are so appreciated by us, and the village of West Wratting.

#### Fundraising

We thank Nigel Job for organising the Shoot event and Richard and Jackie Clarke for continuing to support the Church by hosting the shoot. The date for the 2025 shoot is fixed for the Saturday the 23rd August.

### Financial review and Treasurer's report for the year ending 31<sup>st</sup> December 2024

#### General Fund

Covenant giving during the year amounted to £7,705 compared to last year's £7,960 being a decrease of £255. Covenants are the mainstay of our income and ensure we have a regular monthly cashflow to cover our outgoings – our sincere thanks to those of you that support us in this way. This is truly appreciated and is one of our focus points in our discussions.

Voluntary income from gift aid donations was £2,123 in addition to the donation £2,700 from Henry D'Abo both of which are very much appreciated. We did have the benefit of Benefice services which generates funds that we pass onto various charities.

At the yearend We had Gift aid tax claims in process of approximately £7,695 claims from gifts given to us over the past 3 years. (we received in April claims for 2022 and 2023 and a further claim for 2024 to arrive in May 2025)

Other income increased to £2,053 (2023 £864) primarily from funerals and Interests.

Total income for the year increased by £3,371 to £13,981 (2023 £10,610).

We paid 100% of our parish share in 2024, a sum of £7,440 versus £7,169 in 2023.

General expenses increased to £4,602 from £2,653.

#### St Andrew's Restoration Fund.

Income for the year was  $\pm 3,740$  compared to  $\pm 11,436$  of which the Auction of Promises in 2023 raised  $\pm 8,436$ . In addition, we are due to receive  $\pm 2,036$  from Gift aid for claim for the past 3 years donations.

Restoration building support costs £6,808 in addition specific restoration building repair costs of £10,010. The works in 2024 were primarily to safeguard the windows, removing the iron supporting frames, repointing the tips with stainless steel, rust removal and coating with black paint. When they were replaced all the stain glass were rewired to the frames.

Without the generous support of the members of the parish and the most valued support from the various bodies that have awarded us grants we would not have been able to achieve what we have. We are indebted and look forward to continued support.

We took the opportunity of an interest free loan of £15,000 from the Cambridge Historic Churches Trust in 2020, which we appreciate and thank them for. This loan is now fully repaid.

As reported in previous years we must look in 2025 to holding more events if we are to maintain the upkeep of the church fabric.

#### Total Funds

Total funds (excluding CBF investments and sundry school funds) at the year-end within all accounts were £13,090 versus £23,338 in 2023.

#### Charities supported during the year.

We have supported Children in Need, the Royal British Legion, a total of £175.

#### Legacy

There were no legacies received in 2024.







#### **Grants Received In the past**

We are very indebted to the many individuals who have so generously donated to our repair needs in the past years and to the Grants received from Cambridgeshire Community Foundation Wadlow Wind Farm, Church Care, All Churches Trust, Amey Community Fund, Cambridgeshire Historic Churches Fund, NIAS Wheatley Charitable Trust and the AS Charitable Trust without whose support we would not have been able to carry out the various projects in the past few years.

#### **Covenant Giving**

We in West Wratting have a challenge not only to secure the needs of the day running of the St Andrew's and ongoing repairs to the fabric of the Church.

Each child was given a book about Easter to take home, along with their chocolate egg!





### Harvest Songs of Praise Sunday 13 October 2024

It was good to have Rev Hannah Threlfall to join us for the first time to celebrate this service with us. About 60 people came.

The children were invited to bring food items to donate to the REACH charity food bank in Haverhill and we looked at what the Bible says about God having a special heart for the poor.



Phil and Chris Griffen showed pictures of their life in Ethiopia helping particularly needy people. This made us realise just how much we are provided for in this country, and why it is so important to have a Harvest service thanking God for all he gives us.

## Fabric Reports Churchyard



Thanks to many volunteers, the churchyard has been beautifully maintained throughout the year and, as I write, the snowdrops are in full bloom, the primroses are beginning to flower, soon to be followed by the daffodils.

We had our usual Autumn and Spring clear-ups, which were well attended and the customary coffee and doughnuts were administered.

Three trees needed serious attention during the year - a lime and hawthorns on the North side, which appeared to be dying. They have all been pollarded rather than taken down as there are some signs of life up to about two metres, so we are hoping that taking the strain off the roots will enable them to revitalise.

If this doesn't work, then we will have no option but to take them right down. If this happens, we have some young saplings in the graveyard area - wild cherries, oaks, hawthorn, a walnut and a beech, which we may be able to transfer to fill the gaps.

We also pollarded a mature ash on the South side - it had died back - and several large branches had fallen down, creating a danger hazard. All the dead parts have been removed and we hope it can be revived. If not, there are some hawthorns nearby that could replace it. Much crossing of fingers!

There is a whole cohort of volunteers to thank for their great work in the churchyard and I am bound to miss someone out. Apologies in advance:-

Quinquennial report

The quinquennial survey was carried out by our Architect Stephanie Norris on the 15<sup>th</sup> June 2022. Some minor points were identified which we have Completed in addition during 2024 we completed the window repairs and in 2025 we shall complete a small programme of clunch shelter coating and repointing in areas that were not addressed when we completed our major works some years ago. A specialist stonemason (probably Herringbone) will be retained. We don't anticipate this to cost more than £10,000.

When the clunch repairs are complete all the category A and B will be complete.

## The Oil Boiler

The Oil burner has limped on for another year, we are grateful to Ian Timothy for continuing to maintain the Oil burner which was installed in 1984.

## Annual Report on Ministry in the Granta Vale Benefice – 2024

The following report is given in relation to a year of ministry and mission for 2024. This was a year when we celebrated Hannah's ordination as deacon at Ely Cathedral, welcomed Alastair France to our ministry team, held a variety of services in our seven churches -including Taize services, Café Church and Creative Church, saw our

youth groups continue to flourish, and sought to serve people in our local communities and in the wider world. We celebrated holding many weddings and baptisms, and led many funeral services throughout our parishes. Hannah, who was already part of our ministry team as Community Minister, was ordained as deacon at Ely Cathedral on Sunday 30<sup>th</sup> June and hence began leading service as an ordained minister. Alastair France joined our ministry team on placement as part of his vocation discernment process, whilst we continued to benefit from support from ministers outside of our Benefice, in particular from our rural dean Revd Michael Wilcockson. This report reflects our patterns of worship, the pastoral life of our six parishes and the local mission engaged with over the last year. It is also an expression of gratitude to the many people who helped lead and support ministry and mission in our parishes with a mixture of commitment, creativity and compassion.

#### The Ministry Team

This was led by Revd. Iain McColl and included: Revd Hannah Threlfall as assistant curate; Revd Kathy Bishop as associate priest; Alistair Collen and Steven Wheeler as Licensed Lay Ministers; Authorised Lay Ministers Keith Day (Music Minister) and Rosemary Mead (Pastoral Care); music group leader Steve Jordan; and Alastair France on placement with us.

Ministry Team meetings happened fortnightly on Tuesday mornings, usually at 10:45am, and were an important way of members of the ministry team supporting one another. Most members of the ministry team would usually be present, and as well as discussing and planning ministry and mission throughout the Benefice it was an important time of fellowship together.

As Community Minister, Hannah continued to offer valuable contributions to the ministry team well as her wider ministry in our parishes throughout the first half of the year. Hannah was then ordained deacon at the end of June. As an ordained minister, Hannah led Sunday morning services and funeral services as well as continuing to build on the good work she started as Community Minister in leading assemblies and developing contacts with local schools.

We continue to be grateful to Bob Coates for his creativity and energy in supporting the production of short films for ministry. These can be viewed on the Benefice's YouTube channel and were occasionally made available through the email newsletter or via the website. We aimed to produce new films for church festivals and also to go with events held by *Soul Space* at Weston Colville.

We are also thankful to Cazzy Walshe for her brilliant administrative skills, enthusiasm and diligence, her hosting of ministry team meetings, organisation of the email newsletter, managing our website, leading on safeguarding and many other things so important to the organisation of our Benefice. Cazzy often goes the extra mile in supporting ministers, people making enquiries and people in the parish, and in doing so shows a calm, kind and empathetic approach which is very much appreciated.

We are thankful for Rosemary Mead for her co-leading, along with Hannah, *Creative Church* in Great Abington, and for Alistair Collen and all others who have led and helped with *Silent Space* which is based in Hildersham church on Tuesday evenings.

We have been greatly helped by those churchwardens who led services or assisted during services from time to time. We also very much appreciate the work of the sacristans in their preparations for services, Amanda Palmer and Anna McColl for their contributions to the Children's Church Council, those who have helped with 14

children's work on a Sunday, John and Scilla Harvey who have continued to organise the West Wratting *Songs of Praise*, and all those many others who have contributed towards our services throughout the year.

#### **Pattern of Services**

Our pattern of services has generally been as follows: two or three services held at 9:30am; two or three services at 11am; a *Songs of Praise* (four times a year); Café Church monthly at Hildersham; Evensong at 4pm or 6pm and, since July, monthly Taize services at 6pm. We are very grateful for the contributions of the choir led by Keith Day and the music group led by Steve Jordan, and have continued to enjoy the regular contributions of the bellringers. We are also grateful to all those who have supported and led the children's work. United services have involved parishes co-leading and we are grateful as well for all those who have helped with organising and supporting this, including reading, leading intercessions, providing welcomers and refreshments, and helping to clear after the service.

Throughout the year, Holy Communion and Morning Worship services have been held regularly in each village church. Evensong was held in Little Abington, Hildersham and West Wratting; a *compline, 'Silent Space'* held on Tuesday evenings in Hildersham church; and monthly Taize services were started by Hannah at Weston Colville church from July onwards.

We were delighted to celebrate a number of weddings and baptisms this year. Funerals were led by various members of the ministry team and the ministry team were very grateful for the support of churchwardens and organists in leading these.

#### Bellringers

Our services continued to be supported by our wonderful bellringers led by Richard Pargeter at Balsham, Mike Rowland at West Wratting and Ian Ashbridge at Weston Colville. We are very grateful for the beautiful sound of our bells ringing prior to our services and also on those evenings when there is bell-ringing practice.

#### **House Groups**

The House Groups continued to meet for prayer, bible study and fellowship throughout the year. These were led by a range of people, with some groups asking a different member of the group to lead each time.

#### Children's Church Council and Youth Group

The Children's Church Council (CCC) met monthly in Hildersham and continued to thrive, and we are grateful to all those who support the CCC, especially Amanda Palmer and Anna McColl. The Youth Group continued to meet monthly at the Balsham Pavilion and was led by Iain McColl, Karis Reyes, Emma Hilson, Hannah Threlfall and Anna McColl. It's inspiring to have such creative and enthusiastic groups of children meeting as part of our churches and they continue to flourish in fellowship and friendship.

#### The Churches' Choir

The Granta Vale Churches Choir has members representing every parish within our Benefice and met weekly in Hildersham church for practice under the direction of Keith Day. They sang regularly at united services on the first Sunday of the month as well as at occasional Evensongs.

#### Love Abington and Serving our Communities

*Love Abington*, an Abington church initiative, has continued to provide pastoral support to many as well as running regular community-based events. A special thanks to Rosemary Mead, Hannah Threlfall and all from Great or Little Abington who have continued to help support and develop *Love Abington*. 15

As well as supporting many local pastoral initiatives in our villages, we also continued to support REACH in Haverhill and a variety of charities through giving at the first Sunday service, and we are grateful to all those who have helped to support such local initiatives.

#### **Contributions to our Village Magazines**

Members of our ministry team continued to make regular monthly contributions to our village magazines via articles, and regular information was provided in these magazines about our church services and activities, including our online services.

#### **Parish Administration**

Cazzy continued to provide vital support and work as our parish administrator. She has, amongst other things, supported ministers in the preparation of services, including occasional offices, regularly hosted ministry team meetings, acted as the Benefice safeguarding officer, helped prepare rotas and orders of service, produced a weekly email newsletter and maintained our Benefice website. We are very grateful to Cazzy for her administrative skills, willingness to go the extra mile and cheerful support.

## Parish Safeguarding Officer's report - 2024

'Safeguarding means the action the Church takes to promote a safer culture. This means we will promote the welfare of children, young people and adults, work to prevent abuse from occurring, seek to protect those that are at risk of being abused and respond well to those that have been abuse'.

I am pleased to present my Safeguarding Officers Report for 2024, as the PSO for the Granta Vale Benefice, a role which I have held since June 2015.

Representatives from the PCC's agreed jointly on a Safeguarding Policy, approved on 09.07.24, to cover all six parishes. This policy is reviewed annually, is available to view in all the church buildings within our benefice, and is also downloadable from the Granta Vale website. As part of our ongoing commitment to safe spaces in our church buildings we have taken the initiative to put up signs in spaces where children's activities take place. The signs indicate that children using the area should be accompanied by a parent, carer or member of our team who has been DBS checked.

**Website** The Granta Vale website <u>www.grantavale.org.uk</u> clearly sets out our vision which is that we are committed as a group of parishes to actively promote the safeguarding of Children, Young People, Victims of Domestic Abuse and Vulnerable Adults. The website has a page dedicated to safeguarding which not only has local information about how to report any concerns but also has links to the Ely Diocese Safeguarding pages on their website. As the website administrator I ensure that all the links, information and advice are kept updated and current.

**DBS checking** the APCS checking service continues to make the completion of DBS checks a smooth process, especially with the option to upload ID documents electronically. A number of individuals who have undertaken their DBS checks and used this process have reported back to me that it was easy to navigate. The results allow for a fast approval of DBS certificates.

**Training for PCC members** PCC's are reminded that all members of PCC's are required to complete a Basic and Foundation online training course every three years. For those members of the PCC's who are not confident with their 16

IT skills, Revd Hannah Threlfall has organised small group training sessions, which have proved to be not only popular, but also successful with the pass marks.

**Safeguarding Newsletters** The Safeguarding Team at Ely publish quarterly Safeguarding Newsletters which Cazzy forwards to the Church Wardens.

## **Report of the Music Minister**

It is my pleasure to be able to offer you this very brief report regarding musical activity during 2024. From my perspective it is a great joy to be able to sing and make music during the services and I hope you too have found this the case.

Although it has been a great pleasure to be playing again, I still feel something of a part-timer, and I want to offer my most sincere thanks to all those who in my limited availability have stepped up to ensure that most of the service have continued to have music – they are a wonderful team

This has not been a year that has seem exceptional musical developments in our churches, but I remain encouraged that we have been able to enjoy music at most of our services. Notwithstanding my conservative tastes it is a source of pleasure that at some services we have been able to have a variety of instruments in use in addition to the organ.

May I please now make one or two observations regarding specific matters:

#### 1. Granta Vale Churches Choir

The choir are a wonderfully friendly and mutually supportive small group of people who meet regularly for practice and to enjoy each other's company. The aim of the choir is simply to enhance worship by supporting the congregation and contributing solo items where appropriate. We aim to explore a variety of music although I readily confess to a preference for the more conventional styles.

The choir have been pleased to contribute to the monthly United Services in Balsham which has been the main activity in the past year but we remain open to other suggestions and opportunities. We really are a very happy group so, if you feel even the least inclination to sing do, do please join us.

I regret that again I was obliged to desert the choir for the first part of the year but am so grateful to Richard Lloyd for giving them some much appreciated support especially with the Good Friday, Stations of the Cross service

#### 2. Carol Services

Carol services present a wonderful opportunity for singing and worshiping without inhibition and this was certainly the case at those services where I privileged to be present around the Benefice.

#### 3. Organists and Musicians

For a rural benefice we are so very fortunate to have a committed team of accomplished organists and musicians willing to cover most of our services. Without wishing to embarrass anyone I am going to mention them all; John Clenaghan, Steve Jordan, Richard Lloyd, Karris Reis, Peter Richards and Robert Weedon – what a team. Thanks are due also to Robin Halls who once again supported us while he was here over the Christmas period. On behalf of all of us I want to thank you for the warm welcome we itinerant musicians unfailingly receive in all the churches.

#### 4. The Organs

I am pleased to report that the organs in our churches remain in good working order except for Weston Colville where the organ is still in real need of some TLC; I appreciate the PCC there have many and various other calls on their funds but I fear the relatively small cost involved is unavoidable at some point. I am, as always, most grateful to our organ builders Charles and Stephen Hall for the excellent and very cost-effective service they provide to us.

#### 5. Other Opportunities

Once again, I cannot conclude this report without thanking Bob Coates for the "hymn of the week" and his other wonderful visual offerings, I know how much these are appreciated by people far and wide who do not necessarily come to, or indeed do not even live near, our churches.

It has been my pleasure to produce a limited number of "Music Reflections" through the year. I do however hope these reflections are of some interest and always welcome any suggestions or comments you may care to offer both regarding them or indeed any other aspect of music in church

I continue to view the future of music in our churches with hope and encouragement.

## **2024 Granta Deanery Synod Report for Granta Vale**

# In March the Synod met at All Saints' Church, Harston, where Rev'd Mandy Flaherty led us in prayer.

There followed a Lent talk by Rupert Shortt, author and Research Associate at the Von Hugel Institute, St. Edmunds College, based on his book "The Hardest Problem: God, Evil and Suffering",

a meditative reflection on the nature of God, the divine purpose and the nature of providence, in a world beset by suffering and evil. Rupert suggested that the purpose of human life is not just happiness, but is a process of learning self-giving love and true wisdom, a process that has become tragically disordered in our world, but which can be re-oriented to its true goal by God's grace. A difficult but thought-provoking lecture! Treasurer Suzanne Darkins announced that the 2023 Parish Share was met in full, entitling the Deanery to a 2.5% rebate to be shared proportionately back to the parishes. The balances at the end of December 2023 were £7387 in the Deanery Development Fund, £8479 in the Parish Grant Fund and £17064 in the Parish Loan Fund.

Jenny Duke reported that Youthinc was again trying to recruit a youth worker for our parishes. The Deanery Come & Sing event in February planned to raise funds for Youthinc was cancelled due to lack of interest and support but will be rescheduled at a later date.

Michael Wilcockson had met with other Rural Deans and Bishop Dagmar and reported that 7 Granta churches had grown their congregations between 2016 – 2022 (omitting 2 years for the pandemic). Jon Smith will meet with these churches to find out how they did it and whether others could follow their good practice.

Archdeacon visitations will begin in 2025. This audit aims to support churches and flag up any areas of concern. Rural Deans, Clergy and Churchwardens will be involved in these visits.

# The July Deanery Synod meeting was held at St. Mary's Church, Linton, where Rev'd Paul Seaton-Burn opened with prayer.

The July meeting is traditionally the one for discussing finance. The Standing Committee offered 3 options for redistributing the rebate from Ely, assuming that every parish meets its share: i) equally to each parish ii) pro rata iii) by need as decided by application to a committee. Deanery reps were asked to discuss these options at PCC meetings prior to voting in October. The Diocese is expected to ask for an increase of 4.5% in the parish share in 2025.

The Treasurer reported that the balance in the current 3 Deanery funds was £33304 and questioned the need for such large reserves. Lay Chair Andrew Gore provided suggestions as to how the funds could be better utilised in future, once the Rural Dean's expenses have been allocated. Much discussion ensued: a share-out for all parishes, support for Youthinc, setting up a Science Chaplaincy, supporting struggling Granta parishes. Deanery reps were asked to share with their PCCs and report back prior to the next Deanery meeting.

Deanery Synod members expressed disappointment and frustration because the Crown Nominations Commission had not be able to reach the level of consensus required to nominate a new Bishop of Ely. It was hoped the discernment process would recommence in Spring 2025. We need to keep Bishop Dagmar in our prayers.

The Deanery elected the following people to the Diocesan Synod:-

Clergy members: Mandy Flaherty, Kathryn Waite, Paul Seaton-Burn, Simon Scott, Julie Norris, Ed Westrip. There is one clergy vacancy.

Lay members: Jon Smith, Andrew Gore, David Brock, Lizzie Taylor, Jeannie Green.

### In October the Deanery Synod meeting was held at St. Mary and St. Andrew, Whittlesford.

Rev'd Olivia Coles led members in prayer and drew our attention to the beautiful modern stained glass window which was installed in 2022 to commemorate 1000 years of the church and the caring which occurred during the pandemic.

The Rural Dean read from Luke 10, The sending out of the seventy-two, followed by small group discussion. Michael reminded us of the purpose of the Deanery as a means of bringing parishes together to build up the Kingdom of God, to support each other in mission and to develop projects such as youth work which are more 19 effective done collectively. A Deanery Event could be an opportunity to bring parishes together and raise funds for Youthinc. A celebration event was suggested to attract a more diverse group of people.

Newly appointed Deanery Youthworker, Hannah Elphick, was introduced by the Rural Dean. She talked about her earlier life and recent move to Cambridgeshire from the Isle of Man, where her father is a vicar. She works for Youthinc within our Deanery for 60 hours per month, and as a youth worker for Cambridge and District Youth for Christ at No.40, a drop-in centre on St. Andrew's Street. She is currently working in the parishes of Whittleford, Sawston and Hinkledux and is helping to set up mentoring sessions in Cambridge secondary schools. She looks forward to meeting young people in the Granta Vale benefice soon.

A proposal for the Science Parks Chaplaincy was outlined by Kathryn Waite from the working group. The plan is to employ a person who can support all faiths and none and can run services. Funding would come from the Deanery and Science Parks and matched funding then applied for – the Faraday Institute is very supportive. The chaplain's primary role would provide a listening ear in an open environment where Christians and those exploring faith could express themselves and be supported in their faith. It is hoped to make an appointment in April 2025.

Michael thanked all reps for the feedback following PCC discussions on the Deanery Funds - Rebate and Reserves. Most PCCs had supported the pro rata distribution of future rebates according to the respective shares and the meeting agreed to this policy. After some further heated discussion about the use of reserves, the Synod voted in favour of Option 3 (£8500 to be retained for expenses and loans to parishes with the remaining £25000 to be used to support Deanery Mission work).

I would like to remind all PCC members and church congregations that they are welcome to attend any or all of the Deanery meetings each year to listen to interesting talks and take part in discussions. The next Deanery Synod will be on 1<sup>st</sup> April 2025 at St. Mary's, Linton. I am happy to email details and offer transport if needed. If PCC members would like to vote at Synod meetings, do consider becoming a Deanery Representative for your church – I would also be happy to nominate you!
